Procedure for Election of Office Bearers / Executive Committee Members of IWMA at 23rd AGM proposed to be conducted on 20th September 2025

- Election will be held for the following Office Bearers / Executive Committee Members:

- Candidate nominating himself or herself specifically for the post of Office Bearer [i.e., Vice Chairman, Joint Secretary] should have served as Executive Committee Member or as Office Bearers of this Association for a period of two years or more.
- Candidate nominating himself or herself for Executive Committee Member should fulfil the following conditions:
 - Member industry should have become a member of IWMA in the previous financial year itself, namely FY 2024-25.
 - At the time of nomination, the member industry which is nominating the candidate should not have any pending dues (i.e., no pending subscription fees or training fees or seminar fees) with IWMA.
 - One can contest only under the industry category in which the current annual membership fees is paid.
 - The industry category under which the annual membership fees is paid for the current financial year should either match or exceed in comparison with turnover certificate issued by the auditor for the previous year.

Some examples:

- (a) For the current financial year, renewal fee is paid under 'Medium' category. The turnover for last financial year is, say, ₹15 crore. Since last financial year's turnover is above ₹10 crore and below ₹25 crore, it falls under 'Medium' category and hence it is valid.
- (b) For the current financial year, renewal fee is paid under 'Large' category. But turnover for last financial year is, say ₹15 crore. Though ₹15 crore turnover falls under 'Medium' category, since member industry has paid higher fees under

‘Large’ category, it is also valid.

(c) For the current financial year, renewal fee is paid under ‘Small’ category. But turnover for last financial year is, say ₹15 crore. Since ₹15 crore turnover falls under ‘Medium’ category and member industry has paid lower fees under ‘Small’ category, it is not valid.

- Member industry should have valid hazardous waste authorization from TNPCB. In case, hazardous waste authorization from TNPCB has expired, the expiry date should not be more than one year before the date of AGM.
 - Member industry can nominate only one candidate and that too for only one post, else it would result in disqualification of nomination.
- Candidate nominating himself or herself for the post of Office bearer/Executive Committee should submit the following documents:
- 1) Candidate’s Nomination Form.
 - 2) Undertaking from the member industry in the company letter pad with company seal.
 - 3) Photocopy of the “No Due Certificate” for the current financial year, which can be obtained by logging into IWMA Member Self Service Portal at <http://members.iwma.in/>. For any assistance in using IWMA Member Self Service Portal, kindly contact IWMA Secretariat at contactus@iwma.in.
 - 4) Photocopy of the member industry hazardous waste authorization issued by TNPCB clearly showing the expiry date.
 - 5) Certificate from Chartered Account with UDIN indicating the previous financial year turnover. [Applicable for Medium, Small and Tiny Categories. Not applicable for the Large Category.]
 - 6) Candidate Biodata
 - 7) Two colour photos of the candidate.
 - 8) Photocopy of any valid government photo ID.

- Procedure for election of Office Bearer / Executive Committee members are as follows:
 - The last date for receipt of candidate nomination form along with all relevant documents at IWMA registered office is 5:00 pm of 14th August 2025 (Thursday).
 - The IWMA Election Committee will scrutiny all nominations.
 - On scrutiny of the nomination form, the candidate's selection will be intimated to the email provided by the candidate latest by 18th August 2025(Monday).
 - In case the candidate wishes to withdraw the nomination, the candidate can intimate through email to contactus@iwma.in. The last date for withdrawal is 29th August 2025 (Friday).
 - Only members who do not have pending dues (i.e., no pending subscription fees or training fees or seminar fees) with IWMA as of 30th August 2025 are eligible to exercise their franchise during election. It will be considered as no pending dues only when the outstanding amount is credited to IWMA bank account (either through IMPS / NEFT / RTGS / SBI Collect/ Cheque collection) on the above said date. Merely issuing a cheque will not be considered as settling of dues. The cheque amount must be collected into the IWMA bank account.
 - In case of more than one nomination for a single post, election to the Executive Committee of IWMA will be held by secure secret online voting platform, details of which will be shared later.
 - E-voting rights will be enabled for a single email ID for each valid membership ID. The "Legal Contact Email ID" for a member industry can be updated by submitting relevant form to IWMA through membership@iwma.in. The form is available IWMA Member Self Service portal <http://members.iwma.in/>. All email requests sent till 30th August 2025 (Saturday) will be considered for preparing the e- voting list for IWMA AGM 2025.
 - For all other matters, the decision of the Election Committee of IWMA stands final.
